1. Welcome by the President - Dr P Satishchandra President Dr. P Satishchandra welcomed the members.

2. Confirmation of Minutes previous EC Meeting held on 11.2.2012 at Mysore

Minutes of the previous EC Meeting were read by Secretary Dr K N Rajesh. This was approved Proposed by Dr B A. Chandramouli, and seconded by Dr P. Katakol

3. Report by secretary - Dr K N Rajesh

Dr.Rajesh K.N took over as the secretary of KNA from Dr. Suresh Duggani in November 2012. Dr.Raja could not hold the proposed KNACON at Manipal. The Scheduled Midterm Meeting of KNA at Udupi was hence cancelled. KNA Midterm meeting was held at Nimhans on 29.3.2013. During the meeting it was proposed to hold KNACON 2013 at Bangalore. Dr.Thimmappa Hegde, Director of Narayana Institute of Neurosciences accepted the proposal to hold KNACON 2013 in Bangalore during June 2013. Dr Rajesh K N briefed the committee about the activities of KNA, emphasizing on membership drive & on the ongoing KNACON 2013. He also suggested to start a dedicated Email & a website of KNA. MOU of KNA was planned to be hosted on its website. Secretaries report was proposed by Dr. Narayan Panji & seconded by Dr. B A Chandramouli.

4. Report by Treasurer- Dr.Datta Nadgir

Dr Datta Nadgir presented the Treasurers report. Total number of Members were 75, an account is opened at SBI Hubli and PAN number is AABAK3045M. The present balance is Rs.2,10,000/- . It is proposed that Rs 1,00,000 to be kept as long term FD, and 50,000 short term FD. Audited report for the year ending March 31, 2011 to be filed. Unaudited account statement as on January 1, 2012 was presented. It was decided to pay Rs. 500/- per month as a remuneration for secretarial assistance to the Secretary of KNA. The venue for KNACON 2014 was proposed as Shivamogga. It was decided to discuss this matter with Dr. Sivaramakrishna, Dr. A V Nagaraj & Dr. Vaman Shanbhag at the KNA AGM. KNACON 2015 was proposed at Hubli.

7. Membership drive.

Dr. Prashant B Katakol took up the responsibility of enrolling new members for KNA

8. Any other matter with the permission of the chair

Dr. H V Srinivas informed that the term of the present KNA Office bearers is till March 13, 2014. Hence next KNA Elections be considered in Nov/Dec 2013. Dr. Prashant Katakol brought to the notice of the KNA members about the difficulties faced by Neurosurgeons in Rural Karnataka to organize treatment for patients under Suvarna Arogya Suraksha Yojane. It was proposed to hold a separate meeting & submit a memorandum to the State Government.
